The Council will take appropriate action.

Board Member Kim Rodela MOVED that the Highland City Council, acting as Board of Canvassers, certify and approve the Election Canvass Returns from the 2021 Primary Municipal Election and declare Scott L. Smith, Jerry Abbott, Colby Gibson, and Sarah D. Petersen as nominated to proceed to the 2021 General Municipal Election.

The meeting adjourned at 6:08 pm.

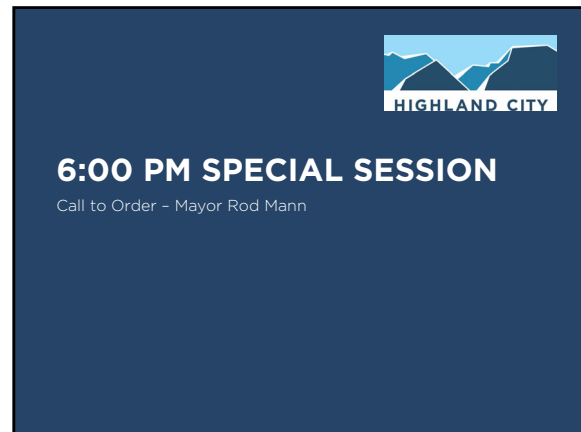

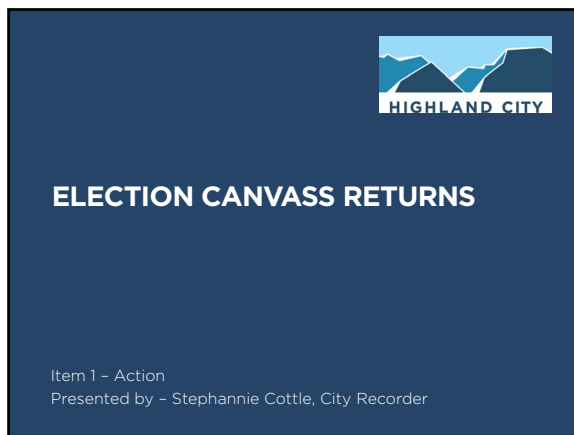

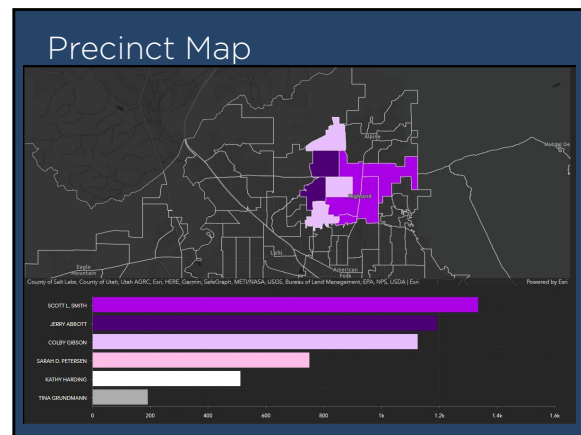
